the core of this edited volume originates from a special issue of the journal of the ottoman and turkish studies association jotsa that goes well beyond the special issue to incorporate the stimulating discussions and insights of two middle east studies association conference roundtables and the important work of additional scholars in order to create a state of the field volume on ottoman sociolegal studies particularly regarding ottoman international law from the eighteenth century to the end of the empire it makes several important contributions to ottoman and turkish studies namely by introducing these disciplines to the broader fields of trans imperial studies comparative international law and legal history combining the best practices of diplomatic history and history from below to integrate the ottoman empire and its subjects into the broader debates of the nineteenth century trans imperial history this unique volume represents the exciting work and cutting edge scholarship on these topics that will continue to shape the field in years to come

in this book umut Özsu situates population transfer within the broader history of international law by examining its emergence as a legally formalized mechanism of nation building in the early twentieth century the book s principal focus is the 1922 34 compulsory

exchange of minorities between greece and turkey a crucially important endeavor whose legal dimensions remain under scrutinized

the final decades of the ottoman empire and the period of the french mandate in syria and lebanon coincided with a critical period of transformation in agricultural technologies and administration chemical fertilizers and mechanized equipment inspired model farms while government officials and technocratic elites pursued new land tenure credit lending and tax collection policies to maximize revenue these policies transformed rural communities and environments and were central to projects of reform and colonial control as well as to resistance of that control states of cultivation examines the processes and effects of agrarian transformation over more than a century as ottoman syrian lebanese and french officials grappled with these new technologies albeit with different end goals elizabeth williams investigates the increasingly fragmented natures produced by these contrasting priorities and the results of their intersection with regional environmental limits not only did post world war i policies realign the economic space of the mandate states but they shaped an agricultural legacy that continued to impact syria and lebanon post independence with this book williams offers the first comprehensive account of the shared technocratic ideals that animated these policies and the divergent imperial goals that not only reshaped the region s agrarian institutions but produced representations of the region with repercussions well beyond the mandate s end

in the nineteenth century ottoman empire traditional religious structures crumbled as the empire itself began to fall apart the state s answer to schism was regulation and control administered in the form of a number of edicts in the early part of the century it is against this background that different religious communities and individuals negotiated survival by converting to islam when their political interests or their lives were at stake as the century progressed however conversion was no longer sufficient to guarantee citizenship and property rights as the state became increasingly paranoid about its apostates and what it perceived as their denationalization the book tells the story of the struggle between the ottoman state the great powers and a multitude of evangelical organizations shedding light on current flash points in the arab world and the balkans offering alternative perspectives on national and religious identity and the interconnection between the two

coins notes fats oils soda waters teas and wines dyes and medicines diplomas certificates patents and titles fakes were everywhere in the late ottoman world did anyone care as this book shows calls to discriminate the true from the fake a founding motto of philological practice from the 16th century onwards prompted many encounters between forgers and bureaucrats in the late ottoman

world each tells a different story about how fakes occurred quoted and translated in full reports of these forgery affairs shed new light on ottoman state society relations they show that the taming of the fake has been crucial to the reforming of the state

the effect of western influence on the later ottoman empire and on the development of the modern turkish nation state links these twelve essays by a prominent american scholar roderic davison draws from his extensive knowledge of western diplomatic history and turkish history to describe a period in which the actions of the great powers incipient and rising nationalisms and westernizing reforms shaped the destiny of the ottoman empire and the creation of the new turkish republic eleven of the essays were previously published in widely scattered journals and multi authored volumes the first of these provides a general survey of turkish and ottoman history from early turkish times to the end of the empire the following essays continue chronologically from 1774 detailing some of the changes in the nineteenth century empire several themes recur one is the impact of western ideas and institutions and the resistance to that influence by some elements in the empire another concerns the diplomatic pressure exerted by the great powers of europe on the empire which amounted at times to direct intervention in ottoman domestic affairs taken together the essays portray a confluence of civilizations as well as a clash of cultures professor davison has written an interpretive introduction that sets out the historical trends running throughout the book in addition he includes a previously unpublished article on the advent of the electric telegraph in the ottoman empire to show how the adoption of a western technological advance could affect many areas of life of particular interest to students of ottoman and middle east history these essays will also be valuable for everyone concerned with modernization in developing nations davison s interpretations and keen methodological sense also shed new light on several aspects of european diplomatic history

the theme of the 2006 international congress of byzantine studies was display assessing what strategies the people of byzantium used to express their thoughts ideals fears and beliefs and how these have been interpreted through various modern discourses the first volume presents the texts of the 28 plenary papers delivered at the congress the second and third contain the abstracts of the many hundreds of papers written for the 64 separate panels and the sessions of communications

however charitable endowments have resurfaced as mosques islamic centers and nonprofit organizations a historical anthropology in dialogue with islamic law god's property demonstrates how these endowments have been drawn into secular logics no longer the property of god but of the muslim community and shaped by the modern state and modern understandings of charity and property although these transformations have produced new kinds of loyalties and new ways of being in society mountaz's ethnography reveals the furtive persistence of endowment practices that perpetuate older ways of thinking of one's self and one's responsibilities toward family and state

in this book martin bunton focuses on the way in which the palestine mandate was part of a broader british imperial administration a fact often masked by jewish immigration and land purchase in palestine his meticulous research reveals clear links to colonial practice in india sudan and cyprus amongst other places he argues that land officials' views on sound land management were derived from their own experiences of rural england and that this was far more influential on the shaping of land policies than the promise of a jewish national home bunton reveals how the british were intent on preserving the status quo of ottoman land law which when few britons could read ottoman or were well grounded in its legal codes led to a series of translations interpretations and hence new applications of land law the sense of importance the british attributed to their work surveying and registering properties and transactions is captured in the efforts of british officials to microfilm all of their records at the height of the second world war despite this however land policies remained in flux

during the nineteenth century the development and codification of forest science in france were closely linked to provence's time honored tradition of mobile pastoralism which formed a major part of the economy at the beginning of the century pastoralism also featured prominently in the economies and social traditions of north africa and southwestern anatolia until french forest agents implemented ideas and practices for forest management in these areas aimed largely at regulating and marginalizing mediterranean mobile pastoral traditions these practices changed not only landscapes but also the social order of these three mediterranean societies and the nature of french colonial administration in nomad's land andrea e duffy investigates the relationship between mediterranean mobile pastoralism and nineteenth century french forestry through case studies in provence french colonial algeria and ottoman anatolia by restricting the use of shared spaces foresters helped bring the populations of provence and algeria under the control of the

state and french scientific forestry became a medium for state initiatives to sedentarize mobile pastoral groups in anatolia locals responded through petitions arson violence compromise and adaptation duffy shows that french efforts to promote scientific forestry both internally and abroad were intimately tied to empire building and paralleled the solidification of western narratives condemning the pastoral tradition leading to sometimes tragic outcomes for both the environment and pastoralists

it is not possible to understand fully the modern egyptian legal system and law withoiut a knowledge of the mixed courts of egypt this book provides essential material for understanding this system and shows the development of egyptian law from its modern origins in 1875 through the social and economic changes of the first world war the 1930s expansion the second world war and the pre revolutionary monarchy it concludes with an assessment of the influence of the mixed courts on the modern system this thoroughly researched work will appeal to both the academic and practitioner involved in middle east law on a regular basis

the history of the holocaust is far from complete even with more than seven decades of holocaust research and writing behind us there are many specialist topics within holocaust historiography that have not been dealt with in detail including the role of turkey this has caused the researchers of the holocaust in other countries to often include limited outdated and sometimes incorrect data about turkey in their studies within the flood of publications on holocaust history that has been rising since the 1990s and which has maintained its momentum ever since studies on the role of turkey remain comparatively underexplored selahattin Ülkümen a turk is the only muslim diplomat who thus far has been designated as righteous among the nations by the yad vashem the holocaust martyrs and heroes authority in jerusalem for saving at his own risk the lives of 42 jews in rhodes from the nazis in 1944 thus momentarily thrust into prominence he excites a certain curiosity however current scholarship has failed to reveal a single monograph or even an article in periodical literature on him neither turk nor westerner has devoted more than a few pages to his exploits references to him in other sources are slight and fall short of explaining a satisfactory explanation of his deeds the remarkable story of Ülkümen is an important but little known aspect of turkish history in the second world war period he is an individual who has not received the attention he deserves this book serves to fill this historiographical void it draws on the previously unused files of the turkish ministry of foreign affairs the yad vashem archives and available primary and secondary sources in turkish english and french

in ordinary jerusalem angelos dalachanis vincent lemire and thirty five scholars depict the ordinary history of an extraordinary global city in the late ottoman and mandate periods utilizing largely unknown archives they revisit the holy city of three religions which has

often been defined solely as an eternal battlefield and studied exclusively through the prism of geopolitics and religion at the core of their analysis are topics and issues developed by the european research council funded project opening jerusalem archives for a connected history of citadinité in the holy city 1840 1940 drawn from the french vocabulary of geography and urban sociology the concept of citadinité describes the dynamic identity relationship a city s inhabitants develop with each other and with their urban environment

in late ottoman south eastern europe traditional ottoman law court systems and court personnel on the one hand and ultra modern french and german austrian law on the other clashed thus more than ever before this region lay on the tectonic boundary of several legal continental shelves this location makes south eastern europe a laboratory in which elements from different legal cultures coexist mutually influence each other and merge with each other a legal space characterised by plurality and hybridity which due to these characteristics ultimately appears more modern than the at least supposedly homogeneous legal areas on the individual legal continental shelves

perhaps the most contested patch of earth in the world jerusalem s old city experiences consistent violent unrest between israeli and palestinian residents with seemingly no end in sight today jerusalem s endless cycle of riots and arrests appears intractable even unavoidable and it looks unlikely that harmony will ever be achieved in the city but with jerusalem 1900 historian vincent lemire shows us that it wasn t always that way undoing the familiar notion of jerusalem as a lost cause and revealing a unique moment in history when a more peaceful future seemed possible in this masterly history lemire uses newly opened archives to explore how jerusalem s elite residents of differing faiths cooperated through an intercommunity municipal council they created in the mid 1860s to administer the affairs of all inhabitants and improve their shared city these residents embraced a spirit of modern urbanism and cultivated a civic identity that transcended religion and reflected the relatively secular and cosmopolitan way of life of jerusalem at the time these few years would turn out to be a tipping point in the city s history a pivotal moment when the horizon of possibility was still open before the council broke up in 1934 under british rule into separate jewish and arab factions uncovering this often overlooked diplomatic period lemire reveals that the struggle over jerusalem was not historically inevitable and therefore is not necessarily intractable jerusalem 1900 sheds light on how the holy city once functioned peacefully and illustrates how it might one day do so again
